

# **ICPDR Operational Plan**

## to ensure Public Participation in implementing the EU Water Framework Directive on the basin-wide ("roof") level

as of September 17, 2004 (consolidated version 2004/2005)


#### **General Outline**

The document ICPDR Operational Plan to ensure Public Participation in implementing the EU Water Framework Directive on a basin-wide ("roof") level (short Operational Plan) is based on the "Danube River Basin Strategy for Public Participation in River Basin Management Planning 2003-2009" (see document for background information and further details), and translates the strategic approach into practical activities ready for implementation. It further develops and adapts the activities suggested in the above mentioned document prepared under the guidance of the RBM EG, and based on the results of the PP Workshop held in Bratislava in April 2003.

The Operational Plan follows the timeframe of the WFD and is linked to the Workplan for the Development of the Danube River Basin Management Plan of the ICPDR. It has to be seen as a "living document" since it will be adjusted and further developed in time, to ensure the successful implementation of the EU Water Framework Directive regarding public participation activities. This document is developed under the guidance and in close consultation with the RMB EG.

The activities described in the Operational Plan should not duplicate ongoing and well-functioning ICPDR processes, but make best use of the existing ICPDR structures and mechanisms. All activities should be planned respecting the limited financial resources.

The Operational Plan distinguishes between three different types of public participation (information supply, consultation active involvement), as described by the graph below:



The following table lists the suggested activities on the "roof" level followed by a detailed description of the activities to be carried out during Stage I and II.

### STAGE I of public participation process – activities in 2004<sup>1</sup>

(5) Organise a basin-wide <b>Danube Day 2004</b> (June 29, 10 <sup>th</sup> anniversary of signing of DRPC), activities in all countries at all levels; outreach programme (cooperation with interest groups, such as DEF, WWF, GWP)	Information supply	ongoing
(6) Further consultation, elaboration and development of the activities of the Operational Plan for stages II-IV under the guidance of the RBM EG (i.e. definition of authority and scope of the Water Council)	Information supply	10/2004

(1) Publish the Roof Report 2004; on the website of the ICPDR, and as a printed document for further distribution. The Roof Report should be made public actively using the media, conferences, workshops, etc	Information supply	01/2005
(2) Good, simple and short leaflet about the outcomes of the Roof Report 2004 for the wider public; if possible this leaflet should be published in the Danube languages.	Information supply	02/2005
(3) Organise the basin-wide <b>Danube Day 2005</b> (29 June)* to specially promote the joint efforts of the Danube Countries to develop sustainable water management (promotion of the Roof Report 2004); outreach programme (cooperation with interest groups, such as DEF, WWF, GWP)	Information supply	June 29, 2005
(4) Further consultation, elaboration and development of the activities of the Operational Plan for the years 2006-2009 under the guidance of the RBM EG (i.e. development of a mechanisms to support, harmonise and fund activities on national and sub-basin level – "external" assistance)	Information supply	11/2005
